# Stallion Service Contract

**Breeding service is subject to the following:**

1. A "Breeder Certificate" will be issued for the foal, conceived by this mating, when stallion fee and all other expenses have been paid in full and when the mare has produced a live foal by this mating.
2. Both parties agree that Hoof Prints Ranch, the breeder, their agents or employees are not liable for death, sickness, and/or accident including consequential damages caused to mare and/or foal.
3. Hoof Prints Ranch makes no warranties or guarantees as to the sex, color, or performance of any foal.
4. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal, which stands and nurses without assistance. If the foal is born dead, there are return privileges for the season \_\_\_\_\_ only if Hoof Prints Ranch is notified in 48 hours and receives a veterinarian's statement confirming death.  
If after being pronounced "safe in foal," the mare should miscarry, abort, or prove barren, Mare Owner has the privilege to a return breeding the following year.  
Mare Owner has 2 calendar years to have a live foal.
5. This contract is non-assignable and non-transferable.
6. This contract represents the entire agreement between both parties. No other agreements or promises, verbal or implied, are included unless specifically stated in contract.
7. Any additional conditions should be individually initiated by each party.
8. Please include a copy of the mare papers to be returned with the signed contract.

**Cooled Shipped Semen service is subject to the following:**

1. The stallion fee includes a non-refundable booking fee of \$ \_\_\_\_\_, payable with this contract.
2. Prior to shipment, the Mare Owner must pay the following in full: balance of stud fee, collection fee, \$ \_\_\_\_\_ normal shipping fee \$ \_\_\_\_\_
3. The Equitainer should be returned by standard overnight or second day air service. If the Equitainer is not returned after 5 days, a \$10 per day fee will apply.
